
*Please take notice that the Court en banc issued a Resolution dated **OCTOBER 8, 2019**, which reads as follows:*

**“A.M. No. 19-10-10-SC** (Re: MCLE Board Resolution No. 06-2019 [Resolution Authorizing the Publication in Newspapers of General Circulation of the Names of Lawyers Who Are Non-Compliant with the MCLE Pursuant to Rule 12, Section 2, Bar Matter No. 850]).- The Court Resolved to

(a) **NOTE** the Letter dated October 7, 2019 of Associate Justice Marvic Mario Victor F. Leonen, Chair, Subcommittee on Maintenance of Membership in the Philippine Bar, relative to Resolution No. 06-2019 of the Mandatory Continuing Legal Education (MCLE) Governing Board; and

(b) **APPROVE** the aforesaid MCLE Governing Board Resolution No. 06-2019, allowing the publication of the list of noncompliant lawyers, arranged alphabetically, in at least two (2) newspapers of general circulation. The noncompliant lawyers shall be given sixty (60) days from the date of publication within which to provide proof of compliance, otherwise, they shall be considered as delinquent and shall not be permitted to practice law.” Inting, J., on official business.
