#### MCLE Governing Board Resolution No. 001-2016

## (Resolution Setting the Maximum Number of Participants in MCLE Lecture Series)

**WHEREAS**, the MCLE Governing Board has reviewed existing policies relative to the over-all conduct of MCLE activities;

**WHEREAS**, there is a need to conduct MCLE activities in a more academic manner so as to offer a high standard of legal education activities and maximize the learning experience of the participants;

**WHEREAS**, interaction and rapport between the lecturer and the participants are essential components of establishing a conducive learning experience and can be achieved if there is limited number of participants in a given lecture;

**WHEREAS**, MCLE activities must approximate classroom setting experience to enable the participants to fully absorbed the lectures;

**WHEREAS**, the monitoring of attendance of participants in MCLE activities is more manageable if the number of participants is set to a reasonable level.

**WHEREFORE**, the MCLE Governing Board resolves to set the maximum number of participants in MCLE activities, as follows:

- 1) For accredited Private Providers affiliated with a law school not more than eighty (80) participants per lecture
- 2) For accredited Law School Providers- not more than eighty (80) participants per lecture
- 3) For IBP National Office including those conducted in coordination with various IBP Chapters- not more than one hundred (100) participants per lecture
- 4) All other accredited Providers not falling under the three (3) aforementioned classification except the Philippine Judiciary Academy (PhilJa) not more than one hundred (100) participants per lecture

In addition to the foregoing, the accredited MCLE Providers are allowed to admit ten (10) more participants who are taking specific subjects only (not the full 36-credit units course), whether pre-registered or walk-in. The number of participants in a single lecture should in no case exceed ninety (90) at any given time for Private Providers affiliated with a law school and Law School Providers, and one hundred ten (110) for all IBP sponsored MCLE activities.

This Resolution shall take effect upon approval thereof.
